Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, particularly one in the nature of a Habeas Corpus (a) Direct Respondent No.4 to forthwith produce the detenu, Sri Kommuri Prakash, son of the petitioner, before this Hon'ble Court and to place on record the authority of law under which he is being detained (b) Direct preservation and production of CCTV footage available at Karthikeya Hotel situated near Guntur Bus Stand, Indian Oil Petrol Bunk near Guntur Bus Stand, Himani Sweets Shop, Majiz Centre situated opposite the office of Respondent No.4, the office premises of Respondent No.4, and other surrounding establishments covering the relevant period from 30.05.2026 to 01.06.2026. (c) Direct Respondent No.7 and all officials working under his control not to act as mediator for showing as today arrest already detenu the petitioner son from 30.05.2026 to 01.06.2026,

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct Respondent No.3 and the concerned police authorities to forthwith secure, preserve and produce before this Hon'ble Court the CCTV footage available at Karthikeya Hotel situated near Guntur Bus Stand, Indian Oil Petrol Bunk near Guntur Bus Stand, Himani Sweets Shop, Majiz Centre situated opposite the office of Respondent No.4, the office premises of Respondent No.4, and other surrounding establishments covering the relevant period from 30.05.2026 to 01.06.2026, as the said footage constitutes vital electronic evidence for determining the actual movements, custody and whereabouts of the detenu, Sri Kommuri Prakash, and pass

IA NO: 3 OF 2026

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents to preserve and produce the blood samples, biological samples and all connected material allegedly collected in connection with the case concerning the detenu, Sri Kommuri Prakash, and further direct that such samples be forwarded to an independent Central Forensic Science Laboratory (CFSL) or any other accredited Central Government forensic laboratory for scientific examination and analysis, through videography/video recording and to place the examination report before this Hon'ble Court, in the interest of justice

ORDER:

- (Per Hon'ble Sri Justice K.Suresh Reddy) The present Writ Petition is filed seeking a Writ of Habeas Corpus to produce the son of the petitioner by name Sri Kommuri Prakash, who is allegedly detained by the 4th respondent.

2. The present Writ of Habeas Corpus is moved by way of house motion and My Lord the Hon'ble the Chief Justice has allotted the same to this Bench.

3. The grievance of the petitioner is that her son by name Sri Kommuri Prakash, was arrested by the 4th respondent on 30.05.2026 at about 7.00 a.m., without intimating the reasons for his arrest, as such, she filed the present writ of Habeas Corpus.

4. Heard Sri P. Mallikarjuna, learned counsel for the petitioner, and Sri Krishna Praneeth, learned Assistant Government Pleader, attached to the Office of learned Advocate General, appearing for the respondent-State through virtual mode.

5. Sri Krishna Praneeth, learned Assistant Government Pleader, attached the office of the learned Advocate General, on instructions, states that the detenu was arrested in the earlier hours of today i.e., on 01.06.2026, as he was involved in Crime No.116 of 2026 of Old Guntur Police Station, registered for the offences punishable under the provisions of The Narcotic Drugs and Psychotropic Substances, Act, 1985. He also states that the detenu was arrested in the morning hours of today i.e. on 01.06.2026 and produced him before the concerned Court in the evening.

6. In view of the above said facts and circumstances, as the detenu was already produced before the concerned Court, the Writ of Habeas Corpus is closed leaving it open to the petitioner to avail appropriate remedies available to her under law, if she has any grievance against the respondents.

Pending miscellaneous applications, if any, shall stand dismissed in consequence.
